## **Article 1 - Short Title**

### **466.1.1 Citation**

This Chapter may be cited as the "Fire Lanes By-law."

## **Article 2 - Interpretation**

### **466.2.1 Motor vehicle - defined**

"motor vehicle" includes any automobile, motor cycle or other vehicle propelled or driven otherwise than by muscular power.

### **466.2.2 Private property - defined**

"private property" means property owned or occupied by a person or persons other than The Corporation of the City of Woodstock, or any local board thereof, and includes property owned or occupied by a corporation.

### **466.2.3 Property owner - defined**

"property owner" means a person whose interest in land is such that he/she is deemed to be an owner under the appropriate land registration system and a person who is or appears to be receiving rent or other compensation from the use of land by a third party whether he/she is receiving it on his/her own account or as agent, trustee or representative or like capacity.

## **Article 3 - General Provisions**

### **466.3.1 Fire route - parking - prohibited - Schedule 'A'**

The private property or portion thereof described on Schedule 'A' forming part of this Chapter is hereby designated a fire route along which no parking of vehicles shall be permitted.

### **466.3.2 Vehicle - parking - standing - on fire route - prohibited**

No person shall park or leave standing a motor vehicle on any fire route on private property designated as such by this Chapter. (See Set Fines)

### **466.3.3 Contravention - vehicle-owner liable - exception**

The owner of a motor vehicle parked or left standing on any fire route on private property designated as such in this Chapter is liable, as is the driver of such motor vehicle, to any penalty provided in this Chapter unless, at the time of the offence, the motor vehicle was in the possession of a person other than the owner or his/her chauffeur without the owner's consent.

#### **466.3.4 Parking violation tags - issue - authorized**

A peace officer or constable or an officer appointed for the carrying out of the provisions of the *Highway Traffic Act* or an officer appointed for the enforcement of municipal by-laws may issue and attach to a motor vehicle found parked in contravention of this Chapter a City of Woodstock parking violation tag alleging that the provisions of this Chapter have been contravened.

#### **466.3.5 Vehicles - in contravention - removal - authorized**

A peace officer or a constable or an officer appointed for the carrying out of the provisions of the *Highway Traffic Act* or an officer appointed for the enforcement of municipal by-laws may, upon discovery of a motor vehicle parked or left contrary to Section 466.3.2, cause such vehicle to be moved from such fire route and taken to and placed in a suitable storage place and all costs and charges for removing, care and storage thereof, if any, shall be a lien upon the vehicle which may be enforced in the manner provided for under the *Repair and Storage Liens Act*.

#### **466.3.6 Signage - property owner responsibility**

Where a fire route has been designated under this Chapter, the property owner shall erect, at their own expense, the authorized signs in accordance with the provisions of Schedule 'B'.

#### **466.3.7 Signage - installed and maintained - by owner**

Where the property owner fails to erect or to maintain an authorized sign under this Chapter, the Fire Chief, fire prevention officer or an appointed municipal law enforcement officer, may enter onto their property described in Schedule 'B' and may erect the authorized sign at the expense of the owner and any costs incurred as a result thereof may be recovered in like manner as municipal taxes under the *Municipal Act, 2001*.

#### **466.3.8 Signage**

Every sign that is required pursuant to Section 466.3.6 shall conform to the requirements set out in Schedule 'B'.

### **Article 4 - Enforcement**

#### **466.4.1 Fine - for contravention**

Every person who contravenes any of the provisions of this Chapter is guilty of an offence and upon conviction is liable to a fine or penalty as provided in the *Provincial Offences Act*.

**466.4.2 Early payment and set fine**

Every person who contravenes Section 466.3.2 is guilty of an offence and subject to a parking infraction notice by way of Part II of the *Provincial Offences Act*, issued by a municipal law enforcement officer appointed by the City of Woodstock. The parking infraction notice shall identify that the early payment for said offence at \$50, and the set fine at \$75.

**Article 5 Repeal - Enactment**

**466.5.1 By-law - previous**

By-law 6790-90 being the former Chapter 466 of the City of Woodstock Municipal Code is hereby repealed.

**466.5.2 Effective date**

The by-law upon which this Chapter is founded came into force and took effect upon the final passing thereof. By-law 8334-07, March 15, 2007.

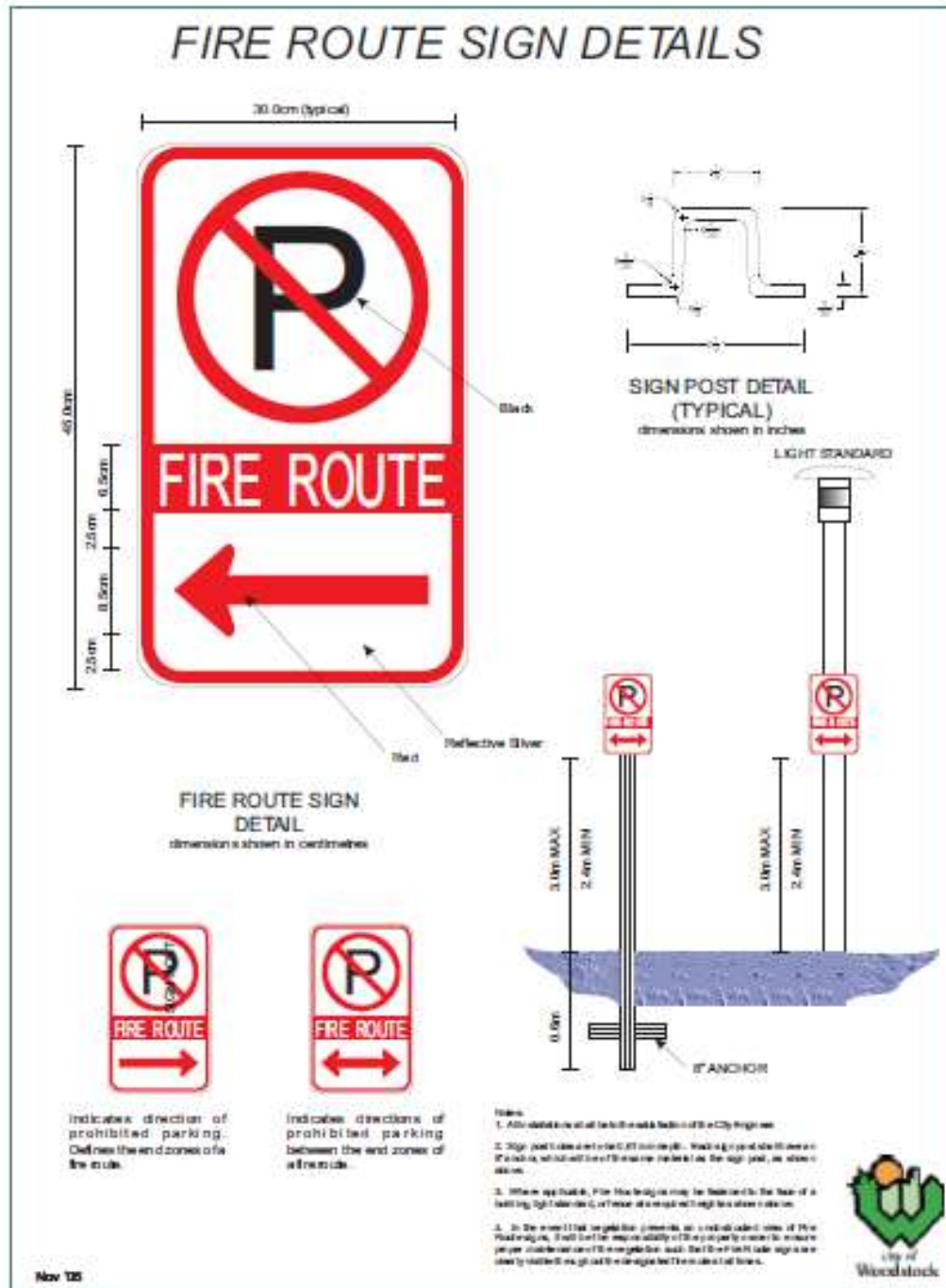

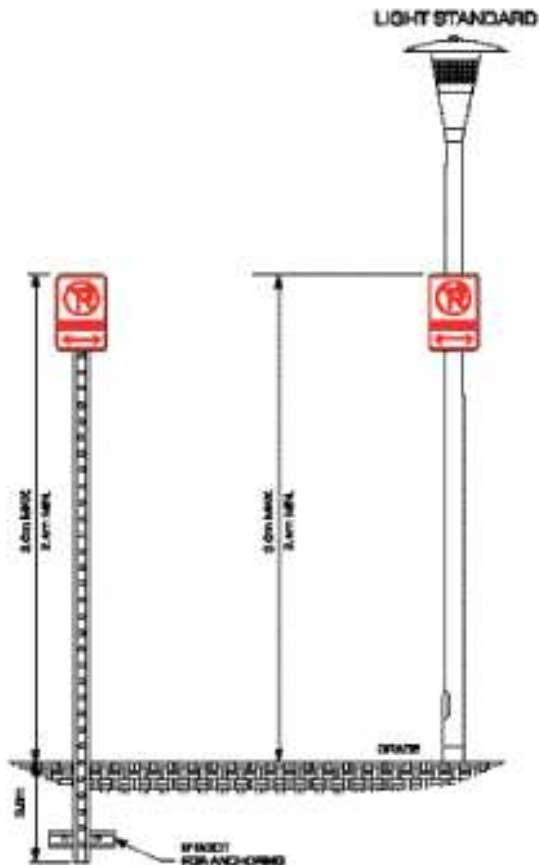

## FIRE ROUTES - DESIGNATION



### TYPICAL FIRE ROUTE SIGN INSTALLATIONS



#### NOTES:

- 1) ALL INSTALLATIONS SHALL BE TO THE SATISFACTION OF THE CITY ENGINEER.
- 2) SIGN POST HOLDS ARE TO BE 80 mm DIA. IN DEPTH. EACH SIGN POST SHALL HAVE AN SPACER, WHICH IS TO BE OF THE SAME SIZE AS THE SIGN POST, FASTENED TO THE BASE OF THE SIGN POST FOR ANCHORING PURPOSES.
- 3) WHERE APPLICABLE, FIRE ROUTE SIGNS MAY BE FASTENED TO THE FACE OF A BUILDING, LIGHT STANDARD OR PERSON AT A REQUIRED HEIGHT AS SHOWN ABOVE.
- 4) IN THE EVENT THAT VEGETATION PREVENTS AN UNOBSTRUCTED VIEW OF FIRE ROUTE SIGNS, IT WILL BE THE RESPONSIBILITY OF THE PROPERTY OWNER TO ENSURE PROPER MAINTENANCE OF THE VEGETATION SUCH THAT THE FIRE ROUTE SIGNS ARE CLEARLY VISIBLE THROUGHOUT THE DESIGNATED FIRE ROUTE AT ALL TIMES.
