127.1.1 Dillon Newton

127.1.4 Director of Parks and Recreation – Parks Supervisor

The Director of Parks and Recreation and the Supervisor of Parks and Forestry is hereby appointed as Municipal By-law Enforcement Officer for the City of Woodstock for the purpose of enforcing the following:

- a) Municipal Code, Chapter 665 - Parks - Regulation;
- b) Municipal Code, Chapter 762 - Trees – Protection;
- c) Municipal Code Chapter 763 – Trees – Protection – Privately-Owned Lands.

- c) Municipal Code, Chapter 835 - Smoke Free Workplaces and Public Places;
- d) Municipal Code Chapter 466 - Fire Routes.

127.1.8 Securitas – specific duties

Personnel of the Securitas are hereby appointed as Municipal By-law Enforcement Officers for the City of Woodstock for the purpose of enforcing the following on the Toyota Motor Manufacturing Canada Inc. property located at 1 71 7 Dundas Street Woodstock, Ontario

- a) Municipal Code Chapter 499 - Parking - Accessible;

b) Municipal Code Chapter 506 - Parking - Private - Public Property;

127.1.9 Oxford County Employee – health inspections

Any employee or class of employee of Oxford County authorized by the Medical Officer of Health to carry out an inspection under the City of Woodstock Municipal Code Chapter 835 are hereby appointed as Municipal Enforcement Officers for the City of Woodstock for the purpose of enforcing the City of Woodstock Municipal Code Chapter 835.
