## CITY OF WOODSTOCK CYCLING MASTER PLAN

The City of Woodstock is in the final stages of developing a City-wide Cycling Master Plan. The Master Plan will include a Cycling Network and Implementation Strategy which will be used to guide the long term planning and development of both on and off-road cycling facilities over the next 20+ years in the City of Woodstock.

The Master Plan will also include:

- Recommendations regarding cycling facility design best practices and maintenance of cycling routes;
- Preliminary layouts of proposed facility designs at several key locations;
- Design and cost estimates by route and implementation phase;
- A suggested funding strategy; and
- Draft policy recommendations to guide the implementation of future cycling routes and cycling supportive initiatives.

You are invited to our second Public Information Centres (PIC) to speak with the study team, give us your input on the cycling network which is being proposed and review draft policies and recommendations. More specifically, the following information will be on display:

- Update on the Results of an Online Questionnaire to Woodstock residents;

- Proposed Route Priorities and Implementation Approach; and
- Recommended Cycling Policies and Promotion and Outreach Strategies.
