CONDITIONS OF VENDING

1. All applicants will be approved by vendor coordinator.
2. Vendors must display and sell only the wares approved on application.
3. Wares are to be sold on registered site only.

A clean-up deposit of \$50 is required for all craft and food vendors, and there is an additional \$50 deposit (\$100 total) required of any open-air fry vendors. Please make this a separate cheque out to The City of Woodstock. Your cheque will be returned upon inspection of the area provided to you.

PUBLIC HEALTH UNIT:

You are required to complete the Southwestern Public Health Special Events Food Vendor Form and submit it to specialevents@swpublichealth.ca, no later than 14 days prior to event. BOOTHS: The fee is **\$150.00** and must accompany the application. Applications will be accepted until, June 21, 2019.

- What we require from you:
 - Commitment with payment
 - Board of health forms to be filled out and delivered or faxed to Health unit.
 - Your own propane handler
 - Clean up your own grease
 - Everything to be taken down the evening of July 1st
 - Honour meal vouchers for volunteers as agreed upon by event organizer
 - Clean up all refuse around your area

NOT SUPPLIED: Canopies, tents, lighting, extension cords.

INSURANCE: All vendors must carry minimum \$2,000,000 liability insurance. Please provide a copy with your application.

*The City of Woodstock is not responsible for lost, stolen or damaged goods during the festival.
It is suggested that all vendors have their own liability insurance.*

Contractor shall indemnify and save harmless the municipality from any and all charges, fines, penalties, and costs that may be incurred or paid by the municipality.

TIME REQUIREMENT: July 1st; 2 PM until closing

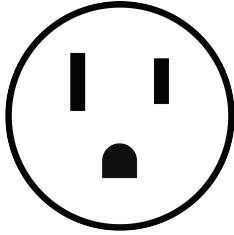
SETUP: July 1, 2019 between 11 am and 2 pm. Enter east and west diamonds at Southside Park from Old Wellington St.

Vehicles must be removed ASAP to nearby designated parking. *No unauthorized vehicle will be allowed to remain on site under any circumstances.*

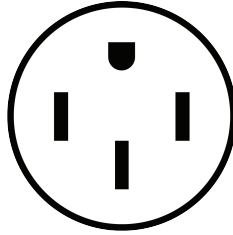
TEAR DOWN: July 1st after 10 pm and crowd has dispersed or unless otherwise negotiated and agreed upon by event organizer

ELECTRICAL OUTLETS OFFERED

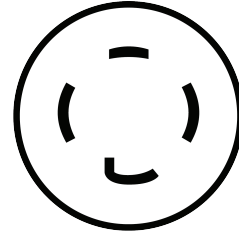
